Privacy Statement United Selections B.V.

General

In this privacy statement, United Selections B.V. explains how it is dealing with the personal data of the users. Any of these data or information which users might share with United Selections B.V., will be stored carefully and confidentially at all times.

United Selections B.V.

The party responsible for processing users' personal data is United Selections B.V.

Personal data

United Selections B.V. processes the following personal data: first name and surname, sex, address, postal code, city, email address, telephone number, customer number, bank account number, payment terms, purchasing history, complaints registration and any other personal data that can be relevant when processing orders.

Purposes of processing personal data

United Selections B.V. is processing personal data only for the purposes described below and for which users have provided United Selections B.V. with their personal data:

- If the user requests United Selections B.V. to provide information about products and services;
- If the user places an order or gives an instruction;
- If the user signs an agreement with United Selections B.V.;
- If the user has signed up to the newsletter;
- If the user is complaining about United Selections B.V.'s products and/or services;
- If the user applies for a job at United Selections B.V..

If the user has provided personal data by visitcard, verbal or written registration for the purpose of a meeting, guided tour on site, fair or any other (commercial) activities, United Selections B.V. shall use these personal data to organise and structure these activities, for instance to send out the invitations, information and/or other relevant documentation.

Legal grounds for processing personal data

Transfer to third parties

ensure that the processor provides adequate assurances as to the technical and
organisational safety measures regarding the processing steps; or

• Pursuant to the statutory requirement, United Selections B.V. is obliged to transfer personal data to the competent authorities.

Retention period

United Selections B.V. shall not retain users' personal data any longer than absolutely necessary, unless United Selections B.V. is obliged to retain personal data for a longer period of time pursuant to a statutory obligation.

Privacy rights

Users have the right to inspect, improve, transfer, correct, supplement, remove and protect their personal data.

Users have the right to be informed about, restriction of, and to object to the processing of personal data.

- To analyse from which counties users come.
